YOGINDRA SAGARJI MAHARAJ PAYS A VISIT TO PRAGATI ASHRAM, UDAIPUR



Pujya Acharya Yogindra Sagar Ji Maharaj spent two days, January 29 and 30, 2005, at Pragati Ashram, the home of a project on women empowerment located in Udaipur, Rajasthan. The project was launched in 2001 to address the needs of three different groups of women: widows, abandoned women, and young women in need of support for pursuing post-secondary education and training. The objective was to provide opportunities to women in the identified groups to acquire basic and post-secondary education and develop employment related skills, so that they could obtain gainful employment or self-employment and pursue other career goals. It was expected that when women in these groups had access to opportunities for training, skills development and education they would be able to realize their full potential, lead a life of dignity and self-worth and participate as equal partners in the development of the society.

The principal partners in the project are M.R. Minda Trust Udaipur India, the Hindu Society of Ottawa Carleton (HSOC) Ottawa and the Canadian International Development Agency (CIDA). The project also received support from other donors, the society at large, and the families of the beneficiaries. The partnership project has completed its targeted duration of three years, but will continue to be operated by the M.R. Minda Trust.



The Trust has constructed a complex of buildings named "Pragati Ashram". The complex provides fully furnished accommodation for 60 to 70



beneficiaries with facilities for meals, exercises and meetings and class rooms. A bus is also provided for transportation to various education and training facilities. In addition, special programs, such as Yoga, outdoor and indoor games, periodic personality development and self-awareness workshops, and computer training are offered. Lodging, boarding, transportation and special programs are greatly subsidized and are, in fact, free for widows and those in need. Pragati Ashram is open to all

women irrespective of caste or creed. At the same time it adheres to its motto of providing a clean, disciplined, moral, and progressive life style.

On the morning of 29 January Acharya Shri addressed a gathering of Pragati Ashram residents and guests. The meeting was also attended by Shri Gulabchand Kataria, home minister of the state of Rajasthan. Acharya Shri commended the Pragati Ashram project for its unique and laudable objective, and its enlightened management. Shri Kataria echoed Acharya Shri's comments. 
ACHARYA SHRI VIJAY NITYANAND JI DECLARED AS PATTADHAR OF VIJAY VALLABH SECT

A DALIT BECOMES A JAIN MONK

In a society, where upper castes treat dalits with disdain and untouchability remains a stigma irrespective of what the Indian Constitution outlines, the induction of a dalit youth in Jain religion comes as a welcome change. In a historic event, a 22-year-old youth belonging to Meghwal community was anointed as a Jain monk at Ahore town in Jalore district on Monday. Hailing from Mandwaria village, Sirohi district, Chandaram Meghwal alias Sandeep got a new identity as Anant Punya Maharaj at a diksha ceremony attended by a large number of people from Shwetambar Jain community and Sandeep's relatives from Sirohi. Sandeep who went to Mumbai in search of a job a few years ago was so impressed by Jain saint Suryodaya Maharaj that he expressed his desire to dedicate his life to the religion. He traveled with him to various holy places and attended religious sermons with deep devotion and sincerity to the surprise of the saint. On expressing his desire to join the religion, he was sent to Ahmedabad to study the Jain ideology for almost four years. He was

given a warm send-off from his village two days ago and reportedly there was a mad rush among the villagers to touch his feet to show their reverence. His monk-hood moved about 1,500 people in the village to go vegetarian and give up drinking. He would be known with his new name Anant Punya, said Mahaveer Jain, a businessman from Bangalore, who was currently in Ahore to attend the diksha ceremony. His 26-year-old sister also took diksha along with Sandeep, A commerce student at the MES college in Bangalore, she gave up her studies to pursue the same path.

BAL DIKSHA OR CHILD WELFARE: A SERIOUS ISSUE

A news item, named "SEND THIS GIRL BACK" appeared in Mid-day, English newspaper in Mumbai, (reported by Manoj Nair, E-Mail: manoj@mid-day.com) on 22nd January, 2005 at page 5, as given below:

Priyal, a nine year old girl, was ordained a nun in a "bal diksha" ceremony held on March, 2004, at malad. Ravindra parekh, a lawyer from her community, filed a petition in the family court "asked for her custody under the Gaurdians" Wards act. Parekh, who is not related to Priyal, argued he was entitled to ask for the child's quardship because her parents had treated her cruelly by ordaining her. But before parekh intervened, a child rights organization, Bal prafulta "Child Welfare Committee (CWC), a statutory state body that investigates violation of children's rights, had filed a complaint with police. Meanwhile, the trustees of the jain temple have petitioned the high court questioning the authority of the CWC in interfering with what they think is "religious" matter.

Two psychiatrists from the Tata Institute of Social Sciences who examined Priyal said the girl appeared "lost "was unsure what diksha meant or the implications it had". They said while girl appeared healthy, she performed rituals recited shlokas, understanding little of what either meant. They said that after turning 18, the girl could decide if she wanted to be a nun. Priyas parents, santosh kumarseems bagricha, work as cooks in a town in Madhya Pradesh. The psychiatrists said the mother was happy her daughter had become a nun, but father cried while speaking to them.

The lawyer representing Chandravadan Jeevanlal Kothari Sangh, the Jain temple trust where Priyal took her vows, declined to comment on the psychiatrists findings, saying the matter was sub-judice. But Parekh, the lawyer who wants to adopt Priyal said, "the issue here is not of Bal- Diksha but that of child's welfare". Had something like this been in any other minority community, would the authorities have dared to challenge the religious matter? No doubt, many of us feel that a person should take diksha only after turning 18, but this was not the way to interfere in our religious matters.

TEMPLES

DATTATREYA'S STATUE WILL NOT BE REMOVED, DECIDES GUJARAT HIGH COURT - PETITION OF JAIN COMMUNITY TURNED DOWN IN GIRNAR CASE - It is reported that Gujarat High Court has turned down for the time-being, the request made in the petition of Jain community for the removal of statue of Guru Dattatreya at the fifth peak of Girnar hills. Jain community, not only in the whole country but also overseas had been very much perturbed over the unauthorised occupation at the fifth peak, installation of Dattatreya's foot prints there and troubling the pilgrims, visiting the place for worship of Bhagwan Neminath's foot-prints (Charan-paduka). Many representations had been sent to Central and state authorities from time to time in this connection but all the efforts have gone in vain. The Court has also not accepted the request for ordering the stoppage of any construction work at the said place. As reported in the press and also in Ahimsa Times in its January issue, Gujarat High Court, in an interim order, had earlier ordered for the removal of Dattatrey's statue and stopping the construction work there. The court has however, now constituted a committee, consisting of a representative of the Gujarat Government, District Collector and Director of Archeology department to collect and study all concerned documents and submit its report on the entire issue within a period of six months. The Court has also ordered the State authorities to arrange for necessary security and protection measures to the pilgrims going to the fifth peak for worship and darshan of Bhagwan Neminath's temple. The decision of the High Court has, therefore, come as a severe blow to the Jain community.

AN UNIQUE REPLICA OF SAMAVSARAN TAKES SHAPE NEAR UDAIPUR



According to the Jain scriptures the site of congregation where the Tirthankars give their sermon is called Samavasaran. Following 12 years of rigorous asceticism when Lord Mahavir attained omniscience he preached his first sermon in a Samavsaran. Built by the Devatas, Lord Mahavir's Samvasaran was neither in a temple nor in a community hall, but outdoors in the most beautiful natural surroundings. An enchanting description of the Samavsaran can be found in Tilloypanati, a 2000-year old scripture authored by Jain Acharya Yati Rishabh.

M. R. Minda Charitable Trust of Udaipur, Rajasthan is constructing a faithful reproduction of Lord Mahavir's Samavsaran as described by Yati

Rishabh. The replica is being shaped out of a gentle hill located on the banks of Lake Goverdhanvilas near the Udaipur Ahmedabad National Highway No. 8, five kilometres from the city of Udaipur. The hill covers an area of about 10,000 square feet. The Samavsaran is laid out in the form of 4 concentric circular terraces, the outermost of which has a diameter of 300 ft. The terraces are subdivided into eight different lands. Four archways (Toran Dwar) located in the four directions provide entrance to the Samavsaran. They have been built from rose coloured Karoli sand stone. Immediately inside the archways and on the first terrace are four white marble towers (Man Sthambh). Also on this terrace is the land of temples (Chaitya Prasad Bhoomi), on which are located four small temples. In addition there are small-scale mansions of Devatas, theatre halls, stepped wells, and 24 live trees representing the Kevalgyan trees of the 24 tirthankars. The land of temples is followed by the land of streams (Khatika Bhoomi). Flowing streams and fountains are being constructed on this land. Inside the Khatika Bhoomi is the land of vines (Lata Bhoomi), where vines and flowers of different kinds are being planted. On the next terrace is located the land of gardens (Upvan Bhoomi). This land is filled with a variety of live trees: Ashok in the east, Saptparni in the south, Champa in the west, and mango in the north. Inside the Upvan Bhoomi is the land of banners (Dhvaj Bhoomi), where flags of different kinds will fly.

The next terrace has the sixth land called the Kalpvriksha Bhoomi, where different trees, such as Parijat, representing the Kalp Vriksha will be planted. Inside the sixth land is the seventh, representing the visitors gallery (Darshak Deergha) from where the audience could have a glimpse of Lord Mahavir and listen to his sermon. From here also they could also witness the beauty of the entire Samavsaran. On the highest terrace is located the eighth land (Ashtam Bhoomi), which is divided by radial lines into twelve sections, which in the Samavsaran were reserved for the seating of gods and goddesses (Devas and Devis), male and female followers (Shravak and Shravika), male and female ascetics (Muni, Aryika), and animals of all kinds. Samavsaran, as its name implies, was a place where all living beings, irrespective of their status, could gather to listen to the sermon of the Tirthankar. At the centre of the Samavsaran are located three raised circular pedestals, one inside the other. These are being built in white marble. On the walls of these pedestals are being engraved scenes from the life of Lord Mahavir. Right in the centre of Samavsaran and on the highest pedestal will be an Ashok tree. Located around this will be four statues of Lord Mahavir in the lotus posture. The outdoor replica of the Samavsaran is the first of its kind. The case is being represented by advocates, S.Shri Phali S. Nariman, Siddharth Shankar Ray, U.N. Bachhawat, Arun Jetley and Gopal Subramaniam.

South India was indebted to the ideas of Jain preachers on ahimsa and right living and their influence could be found in the South Indian literature, art and architecture, philosophical thought and practices, Tamilnadu Governor Surjit Singh Barnala has said. Ram Nivas Mirdha, former Union Minister, said many awards were now surrounded by controversies, but

Sugalchand Jain, Managing Trustee, BMF, said these awards had brought into the limelight institutions and individuals that had been bringing about a silent revolution without fanfare and media attention. JAIN CENTRE CALIFORNIA TO ORGANISE FUND RAISING CAMPAIGN FOR TSUNAMI VICTIMS



In the wake of the devastating tsunamis that hit South Asia, India and Eastern Africa, The Jain Center of Northern California sponsored a musical concert at the Jain Bhawan, 722 S. Main St., on Saturday, Feb. 19. It was preceded by a prayer ceremony and dinner at 4:45 p.m. The concert program consisted of performances by Bay Area Indian musical artists Asim and Madhvi Mehta, Harjeet Singh Mehndi, Darshana Bhuta and Piyush Nagar, and ran until 10:30 p.m. The money raised through sale of tickets will be used for rehabilitation and reconstruction with 100 percent of the money used for victims of the disaster. The Jain Center already has a newly formed special

committee raising funds for the tsunami victims, and has received more than \$65,000 in pledges. The Jain Center's efforts in the past include raising \$250,000 for the victims of the massive earthquake in Gujarat, India in January 2001. The Jains rebuilt homes in two villages in Gujarat; educated children at Veerayatan and Morbi; built and supplied to hospitals; and provided for long-term livelihood support. The Kunaria project, at its completion, was declared an exemplary model by the governor of Gujarat for its speedy execution and cooperation between the government entities and the aid recipients.

On Feb. 20, a group of various sponsors including City of Milpitas and the Milpitas-based India Community Center put together a three-hour presentation featuring an interfaith service led by Dr. Deepak Chopra. Music and entertainment was provided by musician Lisa Loeb, and pledge calls were led by Vijay Amritaj and Malini Alles.

Mr. R. P. Jain while introducing the subject of the day "Jain Religion in Foreign Countries" mentioned about the work of German scholars and indologists in last two - three centuries besides Western academicians interest in Jain studies presently. He also traced the first lecture on Jainism in North America by Virchand Raghavji Gandhi, who at the young age of 26 years only was the official representative of Jain religion at "Parliament of World Religions" at Chicago in 1893 i.e. over 111 years ago. He also mentioned about Mr. Gandhi's first disciple Mr. Herbert Warren, who wrote a short book titled Jainism, which was first published from Britain.

Dr. Atul K. Shah spoke about his background of being a Jain, born and brought up in Kenya, Africa and changing his full time profession to become the Founder Editor of "Jain Spirit" a multi colour, fully illustrated, quarterly international Jain magazine published from Britain.

Dr. Sulekh C. Jain gave a bird's eye view of the Jain community in USA and Canada and their religious activities. He also mentioned about JAINA, Young Jains of America and landmark event of US Congress starting with Jain prayer in May 2001 in celebration of birth centenary of Bhagwan Mahaveer.

Mr. A. K. Jain, founder trustee of Ahimsa Foundation, the editor of Ahimsa Times, emphasised the requirement of understanding amongst all sects and groups Jain society. PETA TO PROTEST AGAINST BENETTON, FOR USING AUSTRALIAN WOOL



PETA urges Benetton, a Delhi based garment store to stop using Australian wool until lamb mutilation and live export of sheep ends. Wearing blindfolds and carrying signs reading "Benetton: Blind to Animal Suffering", members of People for the Ethical Treatment of Animals (PETA) India will gather outside Benetton's South Extension store in Delhi with a giant sheep. The demonstrators will distribute leaflets informing customers that Benetton has refused to ban garments made with Australian wool until a gruesome procedure called "mulesing" (live flaving) and cruelty during live

sheep exports from Australia are banned in that country. The action is part of an intense international campaign to encourage consumers to boycott Benetton until the retail chain takes appropriate action to stop the sheep's suffering: Date: 22 February 2005, Time: 2 pm sharp, Place: Outside Benetton, G/6, South Extension Market Part-I.

"Mulesing" is a crude mutilation in which Australian farmers use gardening shears to carve flesh from lambs' backsides without painkillers as a cheap way to try to reduce maggot infestation, even though more sophisticated, humane control methods exist. When their wool is no longer needed, millions of sheep are shipped to the Middle East through all weather extremes aboard open-deck, multi-tiered ships. Many sick and injured sheep, treated as mere cargo, are thrown overboard or ground up alive in mincing machines. Those who survive the grueling voyage have their throats slit while they are still fully conscious. After years of asking the Australian government to end these atrocities, PETA US announced an international boycott of Australian wool in October 2004 and has already won the support of prestigious retailers Abercrombie & Fitch and J. Crew in the US and George and New Look in the UK. India is the third-largest importer of wool from Australia, accounting for close to \$150 million. Recently, MP Maneka Gandhi sent a letter to 250 Indian retailers urging them to stop using Australian wool. "The 'united colours' of Benetton are turning blood red", says PETA India Campaign Coordinator Mitali Parekh. "If Benetton wants to wipe the blood of millions of sheep off its hands, it must refuse to sell clothes made from Australian wool."

PETA is urging consumers to boycott Benetton until it pledges to stop using Australian wool and is bombarding Benetton with ads and protests around the world to alert the public to the company's support of cruelty. KHARAVELA FESTIVAL: SHOWCASE OF ORISSA'S JAIN HERITAGE

The festival has been named after Kharavela, the mighty emperor of Kalinga, whose glorious activities and achievements have been inscribed in the Hati-gumpha (elephant-cave) dated 1st century B.C. in Udayagiri hills (Kumari-parvat). Kharavela's greatness in history rests not merely on conquests; rather he is remembered as a protagonist and patron of Jainism. The architectural and sculptural grandeur of the rock-cut caves hewed by Kharavela in Khandagiri and Udayagiri are indicative not only of his religious fervor but were regarded as the precursor of the temple architecture that followed during his reign. Khandagiri has 15 caves and the cave numbers 7, 8 & 9 contain the images of Jain Tirthankars. Huge residential blocks carved out of the rocks for the Jain monks are also a big attraction. A temple was also constructed on the

crest of Khandagiri for worshipping Jain shrine in early part of the 19th century. At present, there are five temples where images of Shri Adinath ji, Shri Shitalnath ji and Shri Parshvanath ji are being worshipped.

Jain monks and nuns, except for the monsoon season, move about from place to place, not staying in one place for more than four days. Only in the rainy season, Jain monks stay in one place for 4 to 5 months. These months are known as the Chaturmasa. This is a period of increased religious activity in the Jain community as the laypersons, taking a cue from the monks and nuns, participate in group study, communal fasting, religious rituals, etc. The Chaturmasa is also a time of great religious fervor and increased literary output, as the monks and nuns are all staying in one place for a stretch of 4 months and hence many new Jain publications are released at this time.

The Jains are divided into 2 sects: The Digambaras and the Shvetambaras. The Shvetambaras are further divided into the Murtipujakas, the Sthanakavasis and the Terapanthis. Hence, monks and nuns are classified in the 4 categories of Digambara, Shvetambara Murtipujaka, Shvetambara Sthanakavasi and Shvetambara Terapanthi. Since Jain monks travel extensively and spend the four months of the rainy season in various parts of India, it is a Herculean task to get all their names, where they are staying, their contact information, etc. and bring together this information in one book. The editor is to be credited for doing such a huge combinatory work.

Some interesting data: The largest no. of monks and nuns are in the Shvetambara Murtipujaka tradition. Digambara Acarya Vidyasagara's is the only Jain Sangh where all the monks and nuns are bal-Brahmacharis. No other Jain Sangh has 100% monks and nuns who are all bal-Brahmacharis. 

Judge R.C. Jain directed M.C. Jain, who headed the commission that probed the assassination, the central government and the Central Bureau of Investigation to reply by April 21. Chandraswamy, who once had enormous clout in New Delhi's corridors of power, claimed in a petition that certain remarks against him in the Action Taken Report on the final report of the inquiry commission were "baseless and deserve to be quashed. "He also sought a direction from the court to the CBI asking it not to disturb him, his associates, friends and relations with notices under the garb of investigation. According to Chandraswamy, the Government's Multi-Disciplinary

Monitoring Agency that studied the Jain Commission report had not been able to find a grain of evidence against him.

JAIN MINORITY STATUS REPORT IN THE AHIMSA TIMES JANUARY 2005 ISSUE

CHAIRMAN, JAIN MINORITY STATUS COMMITTEE, DAKSHIN BHARAT JAIN SABHA - I am concerned to draw your attention to the erroneous and misleading report in the Ahimsa Times January 2005 issue on MINORITY STATUS FOR JAIN COMMUNITY. The Supreme Court had given directive on my Special Leave Petition on behalf of the Dakshin Bharat Jain Sabha for the declaration by the Central Government in pursuance of the recommendation made by the National Minority Commission in 1994 and repeated in 1996 that Jain community should be recognized as a minority community. This should be notified by a notification of Central Government for the minority status for the Jain community on all-India basis, on par with the other national minorities such as Muslim, Christian, Sikh, Buddhist and Zoroastrian (Parsi) as notified under the National Commission for Minorities Act, 1992.

It is not correct to state as mentioned in your report that "In response to the Affidavit filed by the Central Government, the Supreme Court has given ruling that under section 30 of the constitution, the decision about according minority status on the grounds of language and religion can be taken by the respective state Governments and not by Central Government". There is an Affidavit filed by the Central government but it is response to the directive given to the Central Government by the Supreme Court in my Appeal on 29th July 2004 to take a final decision on the issue of according minority status to the Jain community as recommended by the National Minority Commission pending for more than ten years. It is in this Affidavit the Central Government cites the 11-Judge Bench ruling in the TMA Pai Foundation case that the "religious and linguistic minorities," who have been put on a par in Article 30, have to be considered State wise."

SAWANT COMMISSION SUBMITS REPORT IN SURESH DADA JAIN CORRUPTION CASE



Justice P B Sawant Commission, which probed corruption charges levelled by anticorruption crusader Anna Hazare in 2003 against Maharashtra minister Mr. Suresh Dada Jain submitted its report to the state government. The government will analyse the 372page-report and take a decision on whether to make the report public or not, Chief Secretary Prem Kumar told reporters in Mumbai. Hazare had accused Suresh Jain, of being corrupt. In return, the minister accused Hazare of corruption. The probe was completed in a span of one-and-a-half years and it involved examination of 119 witnesses. Over 800 documents of about 40,000 pages were also referred to during the



probe. On account of non-cooperation, Mr. Suresh Dada Jain was imposed a fine of Rs 500.

GOLD WORTH RS 6 LAKH STOLEN FROM TEMPLE

Mumbai, January 31: THE Jain Temple on Subhash Road, Vile Parle, was robbed of gold ornaments worth Rs 6 lakhs on Sunday morning. One of the temple's priests and both watchmen have been detained on suspicion.

The robbery was discovered when Bachhoobhai, a trustee and regular devotee, visited the temple in the wee hours of Sunday. "When Bachhoobhai got to the first floor, he found the back door broken and the deity's gold ornaments missing," said a trustee, on condition of anonymity. Bachhoobhai immediately notified the other trustees and called the police. Though the famous, 3,000-sq ft Jain mandir has 27 idols of various deities distributed through its three floors-wearing gold ornaments worth crores-only the idol on the second floor had its rings, necklace and diamond-studded crown stolen.

The police have picked up priest Vishwaram Ravan (55) and watchmen Karansingh Bara (66) and Bogama Kamathi (60) of Sun Securities for further questioning. They believe Ravan, who hails from Rajasthan and had worked as a cleaner-cumserviceman at a petrol pump in the city before joining the temple two years ago, may have been involved. "The job seems to have been an insider's work. We have questioned about 47 people so far, including the masons, carpenters and artisans carrying out renovation work at the temple, and hope to have concrete leads on the robbery soon," said Investigating Officer B S Sonawane.
