RESTORED TO ITS FORMER GLORY, 800 YEAR-OLD IN MOOBBIDRI WAITS FOR RAIN



An 800-year-old tank in Moodbidri town, also called the Jain Kashi, recognised as a national monument by the Archaeological Survey of India has been fully restored to its 13th century glory. Thanks to the initiative of the ASI, the tank is expected to hold water this monsoon, after a hiatus of over 80 years. The tank, built eight centuries ago by Jain chieftains, was locally known as 'Bhatrakere.' The ASI prefers to call it the 'Ancient Tank'. The existence of the tank goes back to the 13th century AD. It coincides with the discovery of the Dhavala Trilogy documents of the Jain Tirthankaras.

The Bettakere was earlier known as 'Bhattaraka kere' (Bhattarakas are chiefs of the Jain monasteries); this tank was reserved for the use of the Bhattarakas. Bhatrakere was built on a one-acre land, and it was about 35-40 feet deep. It used to hold water perennially, and there are records in the mutt to show that the tank was used by the Bhattarakas for ritual purposes. "Restoration work was undertaken such that the original masonry was left untouched, as far as possible. The walls of the tank now are as they were when the tank was originally made. It is dressed in laterite stone, custom-cut from local quarries. Stones were wedged together by sheer alignment, without using any cementing agents. Over 2800 Jains attended the 16th Biennial JAINA Convention in Houston. The event was held at the George Brown Convention Center in Houston, TX from July 1st to July 4th. The conference theme was "Live and Help Live."

The events started with blessings from the many scholars, monks, and nuns followed by dinner and then Gandhi Before Gandhi drama etc. The drama, Gandhi Before Gandhi was a tribute to Veerchand R. Gandhi, a Jain scholar. Mohandas K. Gandhi lived with V. R. Gandhi for several years and during those times M. K. Gandhi learned much about Jainism and Non-Violence as a philosophy and practice.



The next morning started with sessions on Yoga, Medication, and Pratikraman. A beautiful temporary temple was built with two muftis (idols) which were officially opened for prayers. Then a grand procession took place in the large hallways of the convention center with each Jain Sangh carrying their flag. The convention was officially inaugurated by lighting of the candles by Lata Champsee, D. R. Mehta, Sushil Jain, and Dr. Neal Barnard, Udai Jain, and other sanghpatis.


NEW EXECUTIVE COMMITTEE OF JAINA


SPECIAL HONOUR RECIPIENTS OF THE MONTH


NEERAJ MEHTA TO HEAD ICAI CHAIR IN TORONTO, CANADA



A new chairperson has been elected to head the Toronto chapter of the Institute of Chartered Accountants of India (ICAI). Neeraj Mehta, a Chartered Accountant (CA) from India, currently working as a Financial Planner and Investment Advisor in Toronto, was voted to power last week with unanimous consent to the Board of the Toronto chapter. The Certified Financial Planner has worked in many countries including Canada, Saudi Arabia, Bahrain and India. He has a B.Com Honours degree from the University of Delhi and has completed Canadian Investment Management focused on consulting, investment and commercial banking. The new Chairman's first priority will be to increase membership and ensure that more and more Indian CAs in the country participate in the activities of the Chapter. "There are currently around 700 Indian Chartered Accountants living in the Greater Toronto area, out of which 200 are members of the Toronto chapter," said Mehta. "It will be our endeavour that every Indian CA from India benefits from networking and professional development opportunities through our Chapter."

The Toronto chapter formed in 2006, an alumni association for members of ICAI living in Canada, also has a mandate to interact with professional bodies in Canada. "Part of our mandate is to liaise with the professional bodies in Canada like Canadian Institute of Chartered Accountants (CICA), Institute of Chartered Accountants of Ontario (ICAO) and others to increase and enhance the awareness of ICAI and its members to eventually get full reciprocity," said Mehta. Earlier this year, in a historic move, ICAI also signed a Memorandum of Understanding (MOU) with the Canadian Institute of Chartered Accountants (CICA) on reciprocal membership arrangements for Chartered Accountants from Canada and India. According to the MOU, an ICAI member who holds a recognized university degree will be eligible to become a Canadian CA by passing the Canadian Uniform Evaluation (UFE) and meeting the profession's experience requirements. Individuals with a Canadian CA designation will be eligible to become an ICAI member by passing the ICAI's examinations in corporate and allied laws and tax. "This is a significant step in the journey towards achieving full reciprocity in the future for which both the Institutes will continue to work together," says Mehta.

CERTIFICATE COURSE IN MANUSCRITOLGY JOINTLY ORGANISED

In the absence of appropriate scholars, a large number of manuscripts in the form of a rich treasure have remained stored unpublished in Gyan-bhandars, Institutions and Universities in India. It is estimated that about a crore manuscripts are scattered at different places and more significant is the fact that about one and half lakh of Indian manuscripts have been stored for years in South Asia and other Asian countries while sixty thousand of them are believed to be stored in European countries. In the state of Gujarat itself it is estimated that there are about twenty thousand manuscripts stored at different places for years. Out of these one crore manuscripts, only fifteen lakh have been catalogued while the rest have not even been classified.

Recently, under the joint auspices of three organisations, a certificate course of fifteen days was organised which covered two main areas namely, script-reading and script-editing. The three organisations which jointly organised the course were the Institute of Jainology (London and India), Bhandarkar Oriental Research Institute (Pune) and Shri Mahavir Jain Aradhana Kendra (Koba). The students who had registered themselves for the course were imparted theoretical and practical training, both. The course was conducted at the Gujarat Vishwakosh Bhavan in Ahmedabad. The course was inaugurated by Sheth Shri Shrenikbhai Kasturbhai while the chief guest at the function was Padmabhushan Madhusudan Dhaki who emphasised in his speech the importance of the study of manuscripts in various of its aspects. Those who spoke on the occasion were Maitreyee Deshpande, Padmashri Kumarpal Desai, Mukesh Shah, Dhanvant Shah, Kanubhai Shah and Shreenand Bapat.

PRODUCTION OF UK'S MOST EXPENSIVE "AHIMSA MILK" TO BE EXPANDED



Production of the most expensive pint of milk in the UK will be expanded after Hare Krishna farmers in Aldenham agreed a deal with a Kent dairy. Ahimsa milk, costing £2.40 per litre, or £1.70 a pint, is currently produced at Bhaktivedanta Manor, in Hilfield Lane, Aldenham, but officials at the temple have secured a deal to increase production. The Lotus Trust, which manages sales of the produce through its Ahimsa Milk Foundation, has agreed a deal with Common Work Organic Dairy, in Kent, to produce more. Customers in Watford will be able to order the dairy product straight to their door, via a subscription, when production begins in July. The extraordinary produce costs more than double the price of organic milk due to the special treatment the pampered cows receive before and

during milking. The animals, considered holy by the Hare Krishna faith, are massaged during the process and scented candles and soothing music add to the calming atmosphere. No animals are ever slaughtered and elderly cows are given retirement to a sanctuary at approximately 13 years old, safe in the knowledge a pension scheme, derived from milk sales, will support them into their later years. Approximately 65p from every litre sold goes towards the animal's retirement fund, which covers hospice and vet costs. Sita Rama Das, director of the Lotus Trust, said: "It has been a lot of effort to get here and we're happy to provide this service to the public. We are very excited about how this project will develop in the future. "The Lotus Trust has been campaigning for better treatment of cows, and all money gained from this venture will be invested to promote care and better welfare for the animals." DREAM GIRL HEMA MALINI RAISES HER VOICE STRONGLY AT BULL FIGHT IN TAMILNADU



Famous cine-star Hema Malini has approached, Ministry of Environment, Government of India to immediately impose a ban on the bull-fight (Jallikattu) taking place regularly in various towns of Tamilnadu. This so-called game causes serious injuries to the bulls and in many cases, the bulls die due to cruelty during fighting. As a member of PETA, she feels strongly against this game. PETA has also filed a petition in the Supreme Court, which has been accepted for hearing. It is hoped that a complete ban shall be imposed by the Government in near future.

ACHARYA VIDYASAGAR'S BOOK "SILENT EARTH" PRESENTED TO PRESIDENT



New Delhi, The first copy of "The Silent Earth", English translation of the Hindi epic poem "Mukamati" authored by Jain saint poet Acharya Vidyasagar was presented to President Pratibha Devisingh Patil at the Rashtrapati Bhavan. The epic presents the Jain religious philosophy and spirituality by making the soil (Mati) the subject matter as it is from the base clay that the potter artistically crafts the sacred pitchers worthy of worship. He kneads the soil, crushes it, removes impurities and provides the requisite shape at his wheel and then bakes it in a furnace. The process is used as a metaphor for the journey of the soul to attain liberation from the bondage of "Karma" and advance towards a stage of perfect purification.

During the course of the 488-page work, references are made to modern scientific trends, about the destructive power of the atom and faith as the saviour. "Over and above, the machine is thundering, beneath it, the holy incantation is being sung, the one is a killer, the other is a saviour..." goes the poem. A reference to terrorism too comes up. "Till terrorism is alive, This earth can't take the breath of peace," says the Acharya. At another place, the author says about elevation of the soul. "Pay homage to humility which is the mother of eminence..." Among the recurring symbols used in the epic are Mukamati, the heroine as a symbol of the recurrence the life cycle, the potter-artisan, a symbol of the "Mahamuni", the great ascetic who moulds the feelings, thoughts and conduct of a votary householder (the hero) to advance on the true path of spiritualism. JAIN COSMOLOGY

Jains do not accept the theory that there is someone or some power as a creator of the universe. The Jain theory is that the universe has no beginning or end. It is traced to jiva and ajiva, the two everlasting, uncreated, independent and coexisting categories. Consciousness is jiva. That which has no consciousness is ajiva. There are five substances of a jiva:

Dharma	the medium of motion
Adharma	the medium of rest
Akasha	space
Pudgala	matter
Kala	time

Pudgala (matter) has form and consists of individual atoms (paramanu) and conglomerates of atoms (skandha) which can be seen, heard, smelt, tasted and/or touched. According to Jains, energy, or the phenomena of sound, darkness, shade, heat, light and the like, is produced by conglomerates of atoms.

The jiva (soul) has no form but, during its worldly career, it is vested with a body and becomes subject to an inflow of karmic 'dust' (asravas). These are the subtle material particles that are drawn to a soul because of its worldly activities. The asravas bind the soul to the physical world until they have brought about the karmic result when they fall away 'like ripe fruit' by which time other actions have drawn more asravas to the soul.

With the exception of the Arihants (the Ever-Perfect) and the Siddhas (the Liberated), who have dispelled the passions which provide the 'glue' for the asravas, all souls are in karmic bondage to the universe. They go through a continuous cycle of death and rebirth in a personal evolution that can lead at last to moksha (eternal release). In this cycle there are countless souls at different stages of their personal evolution; earth- bodies, water-bodies, fire-bodies, air-bodies, vegetable-bodies, and mobile bodies ranging from bacteria, insects, worms, birds and larger animals to human beings, infernal beings and celestial beings.

The Jain evolutionary theory is based on a grading of the physical bodies containing souls according to the degree of sensory perception. All souls are equal but are bound by varying amounts of asravas (karmic particles) which is reflected in the type of body they inhabit. The lowest form of physical body has only the sense of touch. Trees and vegetation have the sense of touch and are therefore able to experience pleasure and pain, and have souls. Mahavira taught that only the one who understood the grave demerit and detriment caused by destruction of plants and trees understood the meaning and merit of reverence for nature. Even metals and stones might have life in them and should not be dealt with recklessly.

Above the single-sense jivas are micro-organisms and small animals with two, three or four senses. Higher in the order are the jivas with five senses. The highest grade of animals and human beings also possess rationality and intuition (manas). As a highly evolved form of life, human beings have a great moral responsibility in their mutual dealings and in their relationship with the rest of the universe. It is this conception of life and its eternal coherence, in which human beings have an inescapable ethical responsibility that made the Jain tradition a cradle for the creed of environmental protection and harmony. 
SKY IS THE LIMIT FOR OUR POWERS: SUPREME COURT



New Delhi: Amidst criticism of judicial activism, the Supreme Court asserted that sky is the limit for exercising its extraordinary constitutional powers to pass any order in the interest of justice, even if it means bypassing statutory provisions. A bench of justices J. M. Panchal and H L Gokhale passed the ruling while restoring the charge under Section 498A (harassment of wife) by husband or other family members against a police officer A Subash Babu on the complaint of his second wife. The apex court rejected the AP high court's reasoning that since marriage of the accused with another woman during the subsistence of the first marriage was void, the second wife cannot a lodge a complaint under Section 498A. "Article 136 is a special jurisdiction. It is residuary power.

It is extraordinary in its amplitude. The limits of Supreme Court when it chases injustice, is the sky itself. Further, the powers under Article 136 can be exercised by the Supreme Court, in favour of a party even suo motu when the court is satisfied that compelling grounds for its exercise exist," Justice Panchal writing the judgement observed. Under Article 136 the apex court can grant permission to a person to appeal against any order/judgment of the high court or any subordinate court or tribunal. The apex court further said that in bigamy cases, the magistrate can take cognisance of the offence on the basis of a police report also and it was not necessary that there should be direct complaint from victim or some other family member.

POSTAL STAMP RELEASED TO HONOUR DR. D. S. KOTHARI



India Post issued a commemorative stamp on well-known Jain scientist and educationist, Dr.Daulat Singh Kothari on 6th July 2011. Daulat Singh Kothari (1905–1993) was an eminent Indian scientist. He was born in Udaipur on 6th July 1905.He had his early education at Udaipur and Indore and did MSC in physics from Allahabad University in 1928 under guidance of great physicist Megh Nad Saha.

He worked in Delhi University from 1934 to 1961 in various capacities as reader, professor and Head of the Physics department. He was scientific advisor to Ministry of defence from 1948 to 1961. He was appointed as chairperson of University Grants Commission in 1961 where he worked till 1973.

Dr. Kothari was General President of the Indian Science Congress at its golden jubilee session in 1963. He was elected President of Indian National Science Academy in 1973. His notable research on Statistical Thermodynamics and Theory of White Dwarf Stars gave him international reputation. 95 PERCENT BENEFITS OF MINORITIES GO TO SIKHS AND JAINS -MAULANA ABDUL HAMEED

New Delhi: Maulana Abdul Hameed No'mani, secretary of Jamiatul Ulama-e Hind said, while talking to media persons here that Delhi State Minorities Commission and Minorities Financial Development Corporation etc. are simply to befool Muslims because Muslims have not benefited from them in any way. Rather, he said, only people belonging to Sikh and Jain communities are deriving the benefits from all the welfare schemes set up and meant for Muslims.

He said that inclusion of Sikhs and Jains among minorities itself is beyond comprehension, adding that "minorities" can be declared those communities which have their own personal laws but Sikhs and Jains do not have their personal laws. He said that the Ministry for Minority Affairs was created at the Centre to identify and understand the problems and difficulties of Muslims and for their solution and progress but Muslims are not getting any benefit from this ministry also.

He said that the government had appointed Sachar Committee to assess the situation, problems and difficulties of Muslims but after the submission of its report, the then minister of minorities affairs Abdur Rahman Antulay changed the word 'Muslim' to 'minority'. Today, he said, the position is that 95 percent benefits of the schemes made for the welfare and development of minorities are derived by Sikhs and Jains whereas Muslims are not getting the benefits of even the remaining 5%. He said that if the government wants to take Muslims out of backwardness, it should prepare schemes not in the name of minorities but solely in the name of Muslims.

On the other hand, nationalised banks, which are all government banks, have blacklisted Delhi's Muslim-populated localities like Jamia Nagar, Jama Masjid, Seelampur, Mustafabad etc. and because of this, Muslims do not get loans from them. He demanded that the Reserve Bank of India should issue strict instructions to all banks in this connection so that Muslims also should derive benefits from banks.
